Collections, exhibitions and works of art - Over 300 works of art from the permanent collections are always on display. Examples of our masterpiece-quality works include Claude Monet, Brice Marden, John Singer-Sargent, Francis Bacon, Frank Stella, Cecily Brown, Phillip Guston, Jean Arp, Andy Goldsworthy, Constanin Brancusi, Louise Bourgeois, and Alberto Giacometti. In addition, twelve special exhibitions were presented in 2017. These exhibitions contributed to the dialogues surrounding contemporary art and included Alchemy: Transformations in Gold; Ruptures; and Drawing in Space. We highlighted our permanent collections in smaller shows, such as When the Dog Bites, When the Bee Stings; Wild Life; Giacometti; Studies, Drafts, Sketches; Planetarium; I, Too, am America; Fink/Winogrand; and the Irrational and the Marvelous. Responding to our home state, we presented the Iowa Artist, Yun Shin. We published two major catalogs and several smaller brochures to accompany these projects in addition to a video series highlighting the work in Drawing in Space. Artworks entering the permanent collections came from all corners of the world, showcasing the diversity of our holdings and fulfilling our desire for multiple audiences to "see themselves" in the museum. In 2017, we acquired important works of art through gift and purchase byby Glenn Brown, Elie Nadelman, Rachel Sussman (site

Education - The Art Center's public and educational programs are committed to connecting people and art by offering opportunities for feeling, imagining, dreaming. Furthermore, we aim to promote curiosity and embrace critical and empathetic thinking with a spirit of openness, striving to be a welcoming and equitable cultural resource. Our efforts include operating a public art school, engaging in partnerships with more than 30 social and human service organizations, offering on- and off-site school enrichment curricula, creating opportunities for child-centered learning and family engagement, leading guided visits of the museum and Pappajohn Sculpture Park, and hosting varied public events that foster continued learning. Three terms of classes and workshops including animation, ceramics, drawing, jewelry making, painting, photography and more are offered annually and served approximately 3,100 students (children, adults, and families) in 2017. Of those students, approximately 4% (or 130 people) received scholarships. Our art access programs, comprised of six areas of focus, served more than 1,800 youth and adults from under served communities. The areas of focus include curriculum around art and literacy, gender specific issues, multiculturalism, school enrichment, confidence and strength building, and mentor/mentee programs. Schedule D, Part III, Line 4 - In keeping with its mission, the Foundation collects works of art from the 19th, 20th, and 21st centuries. Its permanent collections focus on masterpiece quality post 1945 and contemporary international art and are acclaimed for the scholarly import awarded to them. Of the approximately 5,000 objects in the collections, approximately 3,000 are works on paper that range from Rembrandt, Goya, and Durer to the present. There are regular presentations of artworks in the exhibition galleries at the Foundation. Selected objects from the permanent collections are shown as part of special exhibitions either at the Foundation or in museums throughout the world. When not on exhibit at the Foundation or on loan to museums for temporary exhibitions, the objects are cared for in climate controlled storage areas. The Foundation maintains policies and procedures addressing the collections' upkeep, as well as other aspects of its management, including accession and deaccession policies.

Schedule D, Part V, Line 4 - The Foundation's endowment consists of several individual funds established for a variety of purposes and includes both donor restricted endowment funds and funds designated by the Board of Trustees (the Board) to function as endowments. The Foundation has a policy of appropriating for distribution each year 4.5% of its endowment fund's average fair value over the prior 12 quarters through the second quarter preceding the fiscal year in which the distribution is planned. Single gifts exceeding \$200,000 are deducted from this calculation and a specific appropriation of 4.5% of such gifts is allowed for the 12 quarters following these gifts. In establishing this policy, the Foundation considered the long term expected return on its endowment. Accordingly, over the long term, the Foundation expects the current spending policy to allow its endowment to grow or maintain the principal of the endowment gifts. This is consistent with the Foundation's objective to maintain the purchasing power of the endowment assets held in perpetuity or for a specified term as well as to provide additional real growth through new gifts and investment return.

Interest and penalties on unrecognized tax benefits are classified as other noninterest expense. As of December 31, 2017 and 2016, the Foundation had no material unrecognized tax benefits.
